Associate Membership does not allow for the provision of customised lists or for access to members' information on the website, or marketing consultation.
- A member's liability is limited to £1.
- A copy of the Memorandum and Articles of Association may be inspected during normal business hours at UKFT's Registered Offices at 3 Queen Square, London WC1N 3AR.
- Subscriptions are allowable against Corporation Tax.
- An invoice for VAT purposes will be issued on receipt of payment.
- UKFT reserves the right to decide which companies are eligible to join as Members or Associate Members and in which category.
- Membership is on an annual basis.
- Membership will be automatically renewed. Should a member not wish to continue at any time, three months' written notice of resignation is required.
